HURRICANE PREPAREDNESS

Log on to www.TerryLowry.com and search the archives under "Disaster Preparedness" to hear Harris County Judge Ed Emmett discuss how you and your family can prepare for a disaster.

Houston has seen several major storms in recent weeks with high water in some areas, trees and debris blocking roadways, and power knocked out all over the city. Now that hurricane season is in full swing, are you prepared not only for a hurricane, but wildfires and other disasters?

Would your teenage children know how to survive for 48-72 hours if you were stuck at work due to high water, out of control wildfires, or a terrorist attack? Have you worked out a plan with neighbors in case of an emergency when you cannot be reached?

Are You Ready?

Ed Emmett, Harris County Judge, says you must first prepare an emergency kit. Take your children with you to the store to buy

the necessary food and supplies so they can be aware of what you have available.

In case of a disaster, let your family members know how vitally important it is that they ration food and water accordingly. It is a good idea to have at least 5 days worth of water and food for each family member. For a list of bare essentials, please see page 3.

"It is a good idea to fill a bathtub in the house full with water in case the water system is affected by a disaster," says Ed Emmett. You can use the water in the tub to flush toilets. "If you have empty gallon milk jugs, wash them, fill with water, and freeze," continues Judge Emmett. "These make excellent ice blocks to place in ice chests to keep medicine and milk cold in case the power is out for several days."

Plan with your Children

Talk with your children about different types of disasters and when to leave and when to stay put. The more children know ahead of time, the less traumatic the experience will be. Enlist the help of a neighbor in case you are unable to evacuate with your children.

Ed Emmett stresses the importance of discussing with teenagers where to go in case of a mandatory evacuation and you cannot make it home. Make sure children and teens know who is allowed to help them evacuate and who is NOT allowed. Even though someone is wearing a "uniform", instruct them to always ask for identification before leaving the area with someone.

Most teens have internet access on their cell phones. Instruct them to utilize the *www.HarrisReady.org* website during an emergency to receive updates on road closures, high water, and other important information.

Make sure older children have an emergency credit card or cash in case you are unable to be with them during the disaster. Also, check all vehicle gas tanks and maintenance. Judge Emmett says "it is a good idea to **keep gas tanks at least half full at all times** and maintain the vehicles tires and oil."

Don't Forget the Furry Guys

If you have a family pet(s), remember to include them in your emergency plan. Pets will need food and water too; it's a good idea to buy a small bag of food and several gallons of water to keep on hand.

This year, shelters and emergency evacuation services are allowing small house pets, such as cats and small/medium dogs, access to shelters so owners and pets will not be separated. "If

Contact any elected Republican official and ask them if they have ever given me a bribe or bowed to extortion. I can assure you that the answer will be "no".

Many on a realty board financially support Democrats, abortion providers, and homosexual marriage yet they say they are "conservative". Shame on them for fooling the voter.

Surprise. Surprise. Surprise.

Twenty years ago it was easy to vet candidates. Certain consultants only worked with pro-choice candidates. Certain donors only gave to pro-choice candidates. Certain clubs and newspapers only endorsed pro-choice candidates. Discovering this made making endorsements clear-cut.

Then, in about 1998, many candidates had an 'awakening'. Once pro-choice, they had a sudden change of heart and switched to the "pro-life, pro-family" spectrum. But, many were still "closet pro-choicers".

you are separated from your pet during a disaster, it's much easier to reunite the owner and pet if there is a recent picture available," says Ed Emmett. Also, make sure your pets have a collar with their name, your name, home address, and phone number on the tag.

Utilize 211 for Seniors and Low-Income Residents

Ed Emmett says there is a wonderful - **and free** - service available for senior citizens and low-income families. By calling 211 and placing their name on a list, seniors and low-income families can receive a free ride to a shelter or relatives house during a disaster.

Call 211 as soon as possible to ensure that your name or a relative's name is placed on the list. Even if you have been on the list in previous years, make sure you call again, especially if you have moved or if your medical situation has worsened.

People who are on daily medication(s) need to make sure they have enough pills for a minimum of 5 days. If your insurance carrier allows you to purchase extra pills in case of an emergency, take advantage of that policy. If not, double check the amount of pills you have every few days so you don't get too low.

Most importantly, stay informed. Listen to the news and weather reports daily for updates - not only for hurricanes but droughts and other disasters as well. **Sign up for emergency messages from Harris County at** *www.HarrisReady.org*

The wildfires that hit Texas last year were catastrophic. Many people were not prepared for fire disaster. The loss of a home can be replaced, but a person cannot be.

Basic Needs Survival Kit:

- Dried non-perishable food, such as beef jerky and canned meats and fruits, energy bars and shakes, nuts and raisins, instant coffee
- Water enough for 1 gallon per family member per day for 5 days
- One week supply of diapers and formula for babies
- Manual can opener, toilet paper, paper towels, and garbage bags
- Paper plates and plastic utensils
- First-aid kit, including hand sanitizer, disinfecting wipes, and extra medicine
- Travel-size soaps and extra clothing for several days
- Sunscreen and insect repellant
- Large packages of batteries for flashlights and radio
- Flashlights one for each member of your family
- Battery operated radio
- State road maps and basic car care supplies
- Several gallons of gasoline
- Charcoal, lighter fluid, and water-proof lighter to cook on outside grill
- Store important documents in a water-proof bag, such as a gallon zip-lock
- Don't forget your pets food, water, and medicine for at least 5 days, pet carrier, pet bed, and leash
- **Plenty of Cash** ATM's and cash registers to buy groceries and gas may not be working

David Medina's Easy Ride And Sketchy Record

The Texas Supreme Court (TSC) is comprised of one Chief Justice and eight Associate Justices who are elected in staggered six-year terms. All voters in Texas elect these Justices in partisan elections.

The TSC is the last resort for cases that involve civil matters, including cases involving juvenile delinquency. The TSC settles Texas Constitutional disputes and other cases which involve homeschooling or the Texas Education Agency's purview over the Texas Board of Education.

Politically Motivated Appointment

David Medina, a candidate for Texas Supreme Court, Place 4, gained his current TSC position through a politically motivated appointment in 2004 by Governor Perry.

Suspicion of Drunk Driving

But why would Medina even be considered for this position when, in 2002, he was pulled over by a Harris County Constable on suspicion of drunk driving? During the traffic stop, Medina refused to identify himself, smelled of alcohol, could not walk steadily, failed an eye-movement test, and refused to take a breathalyzer test.

Medina hired Rusty Hardin, a high-priced lawyer, pled guilty to a lesser offense, and only had to pay a \$500 fine. The rich and powerful always got off, it seems.

Who Has First Lien?

Then, in June of 2006, the Medinas were sued by their home mortgage company because the family had missed five months of payments. The investigators soon learned that the Medinas also owed \$1,900 in fees to their homeowners' association.

What happened next shocked the political world and the Medina's quiet neighborhood in Spring, TX to the core.

Who Burned the House Down?

Mrs. Medina was accused of setting a blaze to their spacious home with an accelerant found in their garage. The fire caused nearly \$1 Million worth of damage to three homes in their neighborhood, including their own 5,000 sq. foot home.

Ironically, the losses from the fire were not covered because the Medina's homeowner's insurance policy had lapsed. After the fire, the Medinas sold their home in Spring and moved to Austin, Texas.



Both Medina's Indicted

In 2008, a grand jury returned felony indictments against Texas Supreme Court Justice David Medina and his wife. For the felony, Mrs. Medina's bail was set at \$20,000. Medina was indicted for tampering with evidence (a felony), and his bail was set at \$5,000.

To show how politically rotten this whole situation became, then-District Attorney Charles A. Rosenthal Jr. decided to dismiss the grand jury's indictments because of a "procedural" error made by the DA's office.

Again, The Rich and Powerful Get A Free Pass

Both the grand jury foreman and the assistant foreman (an experienced civil trial lawyer) said the DA's office had already decided beforehand to oppose the indictments against the Medinas. The foreman stated, "If this was David Medina, truck driver of Baytown, Texas, he would have been indicted three months ago."

Even though the grand jury had returned guilty indictments against both the Medinas, the DA's office managed to get the judge to void the grand jury's vote. To keep the grand jury members from telling their side, the prosecutor placed an injunction over them that gagged them from talking under threat of jail time.

David Medina Breaks Campaign Laws

In 2001, 2002, and 2003 David Medina chose not to comply with the campaign finance laws. In 2008, the Texas Ethics Commission brought ethics complaints against Medina because he improperly paid himself \$57,000 from campaign funds. He escaped with a fine of \$35,000.

In the last two years, Medina has given unlawful donations to PACs, used campaign funds for personal use, and failed to report a contribution of \$5,000 from Texans for Lawsuit Reform.

Bottom-line: Why would Texans even think about electing David Medina to the highest court in Texas when he has the kind of criminal and ethics record that would keep any average person from even being considered for office?

Au Revoir France

In the recent French presidential election, Nicolas Sarkozy was narrowly defeated by Francois Hollande. Faced with an increasing financial crisis and raging unemployment, Sarkozy had championed cutbacks in government spending. During a recent trip to Chicago, I couldn't help but notice the large number of homeless people in the downtown area, including one homeless man pushing a child in a stroller. Homelessness was frequently discussed during the 1980's, but receives less media attention now, even though the problem is nearly twice as expansive.

Homelessness, like any other social problem, is influenced by incentives. Unfortunately, government policy may actually be making the problem worse, particularly government-subsidized housing for the poor.

Government Policy Enabling More Homelessness

Many cities have constructed homeless shelters to provide a place for the homeless to stay out of the cold. By the late 1980's, governments had created a network of shelters and soup kitchens to feed and house between 200,000 and 300,000 people per day. By 1996, roughly 607,000 beds were available as part of the homeless service system in the United States.

While advocates for the homeless recognize that there is little evidence to suggest that governmentprovided shelter has in any way

solved or even reduced the problem of homelessness, many believe that providing other forms of government assistance, such as food-stamps or a welfare check, will help people avoid homelessness or escape it. In truth, lack of affordable housing is not the main reason that people become homeless, although it may be a contributing factor in some cities.

Oftentimes, providing government-funded services to the homeless with no strings attached only makes it easier for some of them to continue their bad habits. Christopher Jencks, the Malcolm Wiener Professor of Social Policy in the Kennedy School of Government at Harvard University, argues that shelters made homelessness less painful; meaning that the homeless

were "less willing to sacrifice their pride, their self-respect, or their cocaine fix" to avoid homelessness.

Homelessness and the A.D.M. Syndrome

People sometimes become homeless due to habits or addictions that lead to mismanagement of their finances, unstable family relationships, and the inability to keep a regular job. According to Martha Burt of the Urban Institute, three quarters of those who are homeless report having problems with alcohol, drug abuse, or mental illness – the A.D.M. Syndrome.

For many people, the availability of shelters seems to increase the incentive to become homeless rather than (if possible) choosing to live with a relative or friend. Many single-parent families would like to move into government-subsidized housing, but must wait years for a subsidized apartment to open up. By becoming homeless, a family who was living in someone else's home can move to the front of the line for government-subsidized housing.



Government Programs Are Ineffective

Government programs that try to provide people with skills and treatment to overcome addictions are equally problematic, expensive, and have low rates of success. The success rate of private programs is much higher than government programs - as high as 85 percent. Successful private programs usually continue to attract donors and volunteers, including former homeless people who themselves have been helped.

It is only natural to feel sympathy for the plight of the homeless. The solution to homelessness, however, is not more handouts from govern-

ment. Homelessness can be prevented or overcome when a caring community helps those at risk to develop self-discipline and a good work ethic. This is not easy to do, but some private organizations are already doing good work in this area. Private organizations would be much more effective if government programs were scaled back or eliminated.




